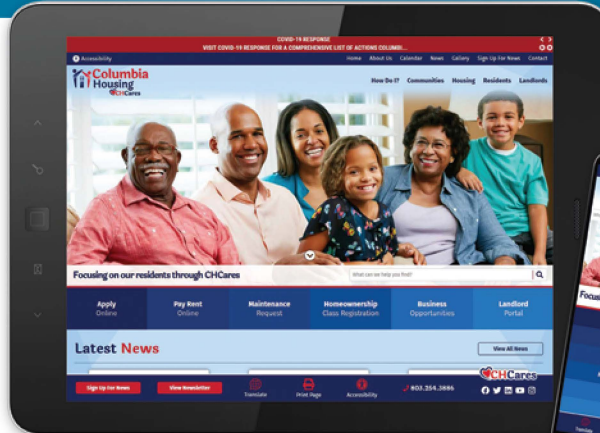

President's Message

Hello SERC Family & Friends...

At the time of this writing, I would generally be preparing for travel to SERC-NAHRO's Annual Conference. As we continue to work through this pandemic, this meeting was canceled. I believe, and I could be mistaken, this is the first time the annual conference has been canceled since 1947. This was during the "Post War Years, 1946-1949" when there was rejoicing over the happy return of many friends who had been away and returning to some sort of "normalcy".

During that time, the 1947 annual meeting was suspended due to the schedule being changed from fall to spring (the previous annual meeting had just been held six months before) as all authorities were concerned about ineligible tenants but did meet in July 1947 in Atlanta for the purpose of discussing the removal of ineligible, over-income tenants.

At this time, the SERC-NAHRO Fall Workshop is still scheduled for November in Myrtle Beach, South Carolina. I would like to add one to two days to conduct business not done in June as well as provide training that has not been accessible to our membership. Information will be forthcoming, and the meeting will only be held if the Executive Committee feels it is safe.

We will celebrate SERC's 80th anniversary at this meeting. On November 19, 1940 in Macon, Georgia, 50 Housing officials from the states of Alabama, Florida, Georgia, North Carolina, South Carolina and Tennessee adopted a Resolution which stated "Be it Resolved by the Housing Authorities situated within the

area comprising Region IV of the United States Housing Authority, assembled in annual session at Macon Georgia, November 19th, 1940, that there shall be organized a regional unit of the National Association of Housing Officials under the following By-Laws..." Thus, the Southeastern Regional Council was created.

While we will not be meeting in June, I am asking the Committee Chairs to hold meetings via conference calls or some other medium for continuity.

We are all deciding what is the most efficient use of the CARES Act Funds received to best protect the Residents, staff & communities we serve.

Today, we are wondering what the "new normal" will look like as many parts of the country continue to reopen and it may take many months to determine. We all are deciding what is the most efficient use of the CARES Act funds received and how we can use these funds to best protect the Residents, staff and communities we serve. Some will return to the office, some will work from home, some will retire as they feel anxiety of returning and others may say business as usual. In some manner, we will all change how we do business.

I again apologize that I have not had the opportunity to visit more of your states as the SERC President, but the current environment does not permit that opportunity. Feel free to contact me via email at mtaylor@ckha.com to let me know how you are doing and share if SERC-NAHRO can assist your agency in some way.

Eight of our ten states have communicated that their associations have canceled their annual and/or fall conferences for the balance of 2020. Only Alabama and Florida are still currently scheduled to meet this August (details on page 28) and



Georgia is planning a virtual meeting in September.

COVID Assistance for Residents



- Alexander City Housing Authority

In response to COVID-19, Alexander City Housing Authority (ACHA) partnered with community organizations to better assess the needs of their Residents via a Resident survey. The survey asked what types of assistance or services would be helpful during this time. The survey responses resulted in the following projects:

ACHA is now a Host Site for the Alexander City schools brown bag lunch program. This program provides breakfast and lunch to school aged children Mon-Fri, helping fill the gap in child nutrition during summer break. This partnership allows more access to Residents and their families by removing the transportation barrier.

Through a partnership with United Way, ACHA has also been able to deliver additional food boxes to Residents and families throughout their communities.

ACHA put together COVID Care Packages for their Residents which included: hand sanitizer, masks, gloves, and sanitizing wipes. ACHA collected enough supplies for a second distribution which will also include cleaning/disinfectant products.

For public housing Residents, ACHA delivered these care packages to each household. For Section 8 participants, ACHA hosted a drive thru to allow participants to pick up their care packages from ACHA volunteers during a set time.

For those who tested positive, ACHA partnered with Servpro® for professional unit sanitized at no cost to the Resident.

Finally utilizing their CARES Act monies, ACHA was able to purchase a mini van to assist with delivery and transport efforts.

A Culture of Giving

Food Brings Hope During COVID-19 Pandemic at Daytona Beach Housing Authority

Recognizing the serious impact to families and the immediate needs as a result of the COVID-19 pandemic, the Daytona Beach Housing Authority staff quickly developed a plan to feed the hungry in their community.

Daytona Beach Housing Authority partnered with agencies across Volusia County, Florida to distribute 600 bags of groceries each week to public housing Residents. The four-month



program, organized by Daytona Beach Housing Authority staff and spear-headed by Executive Director/CEO Terril Bates, coordinates donations of food, supplies, and labor with assistance from partner organizations.

Each week, volunteers bag and distribute free groceries which include fruit, vegetables, cereal, bread, meat, pasta, and household

supplies. The groceries are delivered to the front doors of Daytona Beach Housing Authority Residents to help them endure the hardship resulting from the economic shutdowns related to the coronavirus.

The weekly food deliveries provide healthy meals for families who are staying safe at home and are especially welcomed by those who have lost employment due to shutdowns.

The complex process of feeding the community involves several local agencies including primary partner Halifax Urban Ministries which donated both money and supplies from their stock, Second Harvest, the City of Daytona Beach, and Volusia

County which donated money toward the program and provided use of the county’s Convention Center, the Ocean Center, to be used for assembling the weekly food donations.

Ms. Bates joined Daytona Beach Housing Authority in September 2018 and has been recognized locally for the innovative community programs and Resident-centered initiatives implemented during her tenure. Bates previously served as the Executive Director/CEO of the Spartanburg Housing Authority in South Carolina.

Hickman Heights Groundbreaking Launches Housing Development

Mississippi Regional Housing Authority VI

Mississippi Regional Housing Authority VI (MRHA VI) broke ground for Hickman Heights, a 100-unit affordable housing development on January 30, 2020 at 2 p.m.

This RAD project will cost over \$57 million dollars and is funded by a combination of LIHTC, Bonds and Housing Trust Funds.

MRHA VI in cooperation with BGC Advantage and Mississippi Region VI RAD, LP, developers and co-owners, will rehabilitate 138 units of existing housing and construct 120 new units. This RAD project will impact six central Mississippi counties, creating 633 construction jobs while improving the quality of housing.

This RAD project will cost over \$57 million dollars and is funded by a combination of LIHTC, Bonds and Housing Trust Funds.


Forty-four (44) units within the overall project will be set aside to house

individuals who qualify under the Olmstead Initiative.

The properties within this development are scattered across nine (9) separate sites in six (6) different counties encompassed within the Mississippi Regional Housing Authority VI service area. These counties are: Claiborne, Hinds, Holmes, Madison, Rankin, and Yazoo.

Hickman Heights (Jackson/Hinds County) is named in honor of Executive Direction, Dr. Hickman M. Johnson, and is the first property under construction for the project.

Columbia Housing to Capture 80-Year History; Prepares for ABC Demolition

Through the Years, Allen Benedict Court (ABC) Has Been Home to a Host of Notables

When the first Residents moved into Allen Benedict Court in 1940, an American postage stamp was \$.03, a loaf of bread cost \$.13, one could purchase a brand new automobile for \$450, and Franklin D Roosevelt was President.

Back then, the developer, M.B. Kahn Construction had also recently completed the Gonzales Gardens public housing project just a few blocks away. The two projects, Allen Benedict Court and Gonzales Gardens were basically twin projects with the same property footprint and apartment floor plans. The only difference? Gonzales Gardens was built for Columbia's White citizens; Allen Benedict Court was built for Columbia's Black citizens. In the 80-year life of Allen Benedict Court, it has been home to some of the country's elite, to include a Grammy Award winning performer;


corporate executives; national television celebrities; a host of doctors and lawyers; and NBA greats.

As Columbia Housing begins the process to demolish Allen Benedict Court; the agency is hoping to retain some of the property's rich history by asking former Residents who lived there over its 80-year history to share memories, photos and mementos.

"Our communications team is looking for ways to tell the Allen Benedict Court story," says Interim Executive Director Ivory Mathews. "We have launched the Allen Benedict Court: Always in My Heart webpage. We want to feature their stories on our website and create a table-top keepsake publication to capture the special place ABC has in so many people's hearts."

Martin Enrichment Academy (MEA) provides afterschool and summer programs for the youth of Weakley County, Tennessee.

MEA is coordinated through Martin Housing Authority and its non-profit organization, Impact Management Solutions.

The mission of the Martin Enrichment Academy is to provide an environment that will creatively educate the students and foster a relationship that will last a lifetime.

MEA currently serves 65 students (Kindergarten -12th grade) in the after-school program. **Students' daily schedule includes a healthy snack, academic enrichment activities, recreational activities, tutoring, and homework help.**



MEA staff members work closely with teachers in the local school system to ensure goals and activities align with school objectives. Parental involvement is encouraged and fostered through, volunteer opportunities, parent events, communication with MEA staff....etc.....

Students have opportunities through clubs such as art and culinary to engage in hands on learning.

Northwest Tennessee Local Food Network works with MEA students on a community garden. Students plant, harvest and prepare meals

for the community through the Stone Soup Project.



MEA's summer program continues the enrichment experiences with 40 children (Kindergarten-5th grade) enrolled. The summer program provides a bridge to close the gap on summer learning lost.

The majority of volunteers come from the local university, University of Tennessee at Martin (UTM). Volunteers from several UTM departments actively participate in MEA programs (Social Work, Health and Human Performance, Education, Art Education, and the Paul Meek Library). Members of several UTM sororities and fraternities also volunteer. The UTM Athletic Department provides tickets to students to attend various games during MEA mentor activities with the program.

MEA also benefits from community volunteers, including members from local churches, library staff, and retired teachers.

The programs offered by Martin Enrichment Academy are funded through a variety of sources. The State of Tennessee Department of Education's Lottery for Education Program (LEAP) provides the largest portion of funding for the afterschool program. USDA's Child and Adult Food Program provides a healthy snack for children during the after-school program. MEA utilizes the

USDA's Summer Food Program, which provides a healthy lunch for any child under 18, to feed students during the summer program.

Additional funding is provided by the United Way of West Tennessee and through community donations, specifically **the annual Daddy Daughter Dance fundraiser. The annual event, held for the past six years, has grown from 150 participants to more than 600 participants. In 2019, over \$12,000 was raised for the MEA summer program through the event.**

CARES Act Funding

I was somewhat surprised to open the Housing Authority’s eLOCCS account several weeks ago and discover a large sum of money added for CARES Award.

This CARES Award was funded under the 2020 Coronavirus Aid, Relief, and Economic Security (CARES) Act. To be honest, I have not paid much attention to relief legislation coming out of Washington, D.C., as I have my hands full trying to manage the COVID situation at the local level. However, I was aware that the many of the Affordable Housing Industry Associations have been pushing on behalf of Housing Authorities for relief funding.

If you have not read the HUD Notice - Implementation of Supplemental Guidance to the Federal Fiscal Year 2020 Operating Fund Appropriations (PIH-2020-7) in its entirety, I urge you to do so before drawing down any CARES

Act funding. On May 14, a mass email was issued by the Financial Management Division of HUD indicating that some Housing Authorities have mistakenly drawn down CARES Act funding inconsistent with the guidance provided

in Notice PIH-2020-7. Apparently, some Housing Authorities have drawn down all or as much as 50% of their CARES Act Supplemental Operating Funds, which might not be in compliance with the “immediate needs” requirement. Once drawn down, CARES Act funds must immediately be used to pay expenses.

Any funds that have been drawn down for expenses other than to pay for immediate needs must be returned to HUD.

Notice PIH-2020-7 indicates in several places that additional guidance on the use of CARES Act funds will be forthcoming. Fortunately, on May 29th HUD issued a revised COVID-19 FAQ that covers the use of the funding in much more detail.

In short, this FAQ states that “the funds can cover normal operating and capital funds expenses in addition to the extraordinary uses that arise as PHAs prevent, prepare, and respond to the pandemic.” Regardless of the revised FAQ, I suggest that you proceed with caution.
